

Loans offered in amounts of \$250 (where available), \$500, or \$1,000, 25%, 50%, or 75% of your expected tax refund from \$250 \$6,000. When calculating the amount of your loan, the amount of your "expected" tax refund may be affected by any refundable tax credits. Loans in the amounts of \$250, \$500, and \$1,000 have an Annual Percentage Rate (APR) of 0.00%. Loans in the amounts of \$250. For example, \$2,500 loan representing 50% of expected refund borrowed over 29 day term, total amount payable in a single payment is \$2,571.51 including interest.
